About Kokrajhar Law College

Kokrajhar Law College, the only Legal Education Center at the Bodoland Territorial Council was founded in the year 1985 by the magnificent, far-sighted and noble hearted Advocate Late Niranjan Kr. Narzary of Kokrajhar. His initiative was cooperated by some of these generous persons such as Late Mohani Mohan Brahma, Mr. Rabendra Nath Brahma, Mr. Anil Kr. Brahma, Mr. Dharmeswar Boro, Mr. Debo Prasad Guha, Late Naresh Das and Kishori Mohan Chaudhury and many others.

Late Niranjan Kr. Narzary served as the founder Principal of the college & was succeeded by Sri. Ista Prasad Brahma, former District and Session Judge and Mr. Balladev Narzary (President of Governing Body), with the vision and effort to translate the dream of Late N.K. Narzary into a reality.

Subsequently since its inception the Kokrajhar Law College was able to produce many advocates and legal luminaries for the region, which was much of assistance towards the expansion of legal education; with this continuity of legal education KLC has completed its glorious years of 25 years as the Silver Jubilant in 2010. All through the past years KLC has imparted legal education and produced many capable Advocates, Judges, Magistrates, Law Officers, Human Rights Activists, Social Justice Lawyers and State Civil Service Officers.

The College offers three years LL.B Degree course and also the major course, which is of semester system under Gauhati University. The College is permanently affiliated with Gauhati University and recognized by the Bar Council of India. *A free coaching for preparations for competitive is provided to students for appearing in different competitive exams viz ACS, AJS and others. As the law subject has vast career scope.*

The law courses have been integrated to many specialized courses such as BA. LL.B., B.Sc. LL.B., BBA LL.B, B.Tech. LL.B. B.Com LL.B etc. the KLC also plans to open 5 years integrated course in the future times.

The College is managed by Governing Body formed as per the rules and guidelines of Gauhati University and The Assam Non – Government College Management Rules, 2001 registered under Societies Registration Act XXI of 1860 and is subject to renewal time to time.

At present the college is located at Mwiderkhor Road, Kokrajhar and accommodating basic required infrastructure in 2 (two) storied building. In future the college is likely to be shifted to new sight opposite District Transport Office, Khargaon, Kokrajhar which is under construction. The new campus comprising of 7 (seven) bighas of land along with college building is contributed by the B.T.C Government.

The KLC has informative library with the numerous collections of text books, legal journals, bare acts, reference books, law reports, Supreme Court cases, Gauhati law reports etc. The college holds every necessary academic curriculum as the part of the learning and legal education prospects at regular intervals with the Seminars, Moot Courts, Legal Aid Clinics and Legal Awareness Programs. The college also has e-journal called Manupatra for students to access online articles, books, references that are not available in the library.


KLC solo stands as the only “LEGAL EDUCATION CENTRE” out of 4 districts in BTAD for which we shall always remain proud to be a part of.

The Students' Union

The Kokrajhar Law College has the general student Union by name '**Kokrajhar Law College Students' Union**' (KLCSU) formed every year as per the guidelines of the Lyngdoh Committee. The membership to the union is compulsory for all students admitted in the college. The Union members are eligible to be the office bearers of Kokrajhar Law College Students' Union either through election or selection from the regular students who are pursuing LL.B. course. The Students' Union is maintained to inculcate the ability of social responsibility and acquire the leadership quality from the student life thereby promoting the integrity amongst the students. The Union conducts different activities from sports to social and legal awareness programs. The Legal Aid Cell of the College is also taken care to facilitate the visitors for legal counseling and advice in the college.

Rules and Regulations

Admission Procedure in 3 years LL.B. Course

The Bar Council of India Legal Education Rules 2011 No. 5: (a) **Three Year Law Degree Course:** An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national institution recognized as a Deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three years' degree program in law leading to conferment of LL.B. degree on successful completion of the regular program conducted by a University whose degree in law is recognized by the Bar Council of India for the purpose of enrolment.

The Gauhati University Regulation and Syllabus Clause No. 5. Eligibility for Admission: 3yr. Law Degree Course: An applicant who has graduated in any discipline of Knowledge from a university established by an Act of Parliament or by a state legislature or from an equivalent national institution recognized as a deemed to be University or from a foreign university recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three year law degree course leading to conferment of LL.B. / LL.B (Hons.) degree on successful completion of the regular course.

Provided that applicants who have obtained First Degree Certificate after pursuing studies in distance or correspondence method shall also be considered eligible for admission in the 3yr. law degree course.

An application for admission for the LL.B. course will be done through the online portal under the supervision of the office of the Principal, Kokrajhar Law College as per the public notification. The online applications for the admission is processed through the Admission Committee as per the relevant rules by the Bar Council through notifications, circulars etc. and with provisions of the Gauhati University guidelines for admission. The selected list for the admission at Kokrajhar Law College will be displayed in the website www.klc.ac.in

The online admission procedure will be two stages:

First the students are to submit the online application form filling all the required information by payment of application fee Rs.200.00 (Rupees Two Hundred Only). The user account will be generated for the applied students and it must be kept by student for future reference.

Second the applied students those who are selected for online admission by the college will get admitted by payment of the entire required fees online through the user account created during admission application form through the same portal.

Eligibility:

The applicant must be Graduate in Three years Degree Course from any discipline eg; BA, B.SC, B.COM, B.TECH, etc. securing a minimum pass percentage of 45% marks for General candidates and 42% marks for OBC and 40% marks for S.C./ S.T. to be able to pursue professional degree in law (LL.B) at Kokrajhar Law College under Gauhati University.

Age on Admission:

The age factor for the admission to the LL.B. 3 Years degree course will be as per the guidelines of the Bar Council of India regarding the Maximum age eligibility. At present those seeking admission should not attain the maximum age of 30 years for the General as on 1st June of admission year. The Maximum of 35 years for S.C./S.T. or any other backward community/category with the relaxation as fixed by the Bar Council of India, UGC and Gauhati University Regulations.

Selection Procedure:

The applicants will be admitted on the basis of the merit accordingly the selection list will be notified; however, taking into account the number of applicants the Admission Test or Interview may be conducted. The date for such Admission test or Interview, if conducted will be notified in the Notice Board of the College and website www.klc.ac.in from time to time.

Intake Capacity: 120

Important Regulations:

- No student is allowed to pursue any other full time course of the study during his or her tenure of being student of LL.B. course.
- In case a student fails to attend classes for one month at a stretch from the date of Admission his/her name shall be struck off from the rolls of register.
- The intake capacity in a class is 120 (1st Semester), with 60 students in each section. The medium of instruction and examination is English.
- A candidate who fails to appear in the first due examination shall have to pass in that examination within the period of holding the next two consecutive examinations.
- The every paper as detailed in the syllabus of LL.B. course study shall be of 100 marks with theory 80 marks and internal assessment of 20 marks.
- The students have to score 9/20 in each subject in the internal assessment conducted by the college time to time and 36/80 in the end semester theory examination conducted by the Gauhati University to be able to pass that particular semester.
- The duration of end semester examination for every paper will be of three hours.

How to apply?

A student seeking for admission at Kokrajhar Law College must apply through the given Online Admission application portal through the given link in the website of college. The online filled up admission application form will be shortlisted for selection to admission. The selected students for admission will visit the same online portal and get admitted online. Website is: www.klc.ac.in

Applicants are requested to read the instructions given in the format as well as have to upload some of the documents as stated bellow with duly self attested photocopies along with the admission application form. It is reminded that the documents in original have to be produced as and when college may call for.

Documents required to be uploaded with the online admission application form:

1. HSLC or Equivalent Examination Admit Card (for age proof)
2. Degree or Graduation Mark-Sheet & Pass Certificate (mandatory)
3. Transfer Certificate from institution last attended.
4. Caste/ Tribe Certificate from Competent Authority (If Applicable)
5. Migration Certificate (compulsory if the highest attained degree is from other University except from Gauhati University)
6. Registration Certificate
7. Three recent passport size photograph
8. Gap Certificate (Those graduated in 2018 and earlier).

The payment of entire fees will be during the online admission; payments can be made using debit cards/internet banking through the given portal for online admission.

NB:

1. First Two female S.T. students from BPL family found eligible for admission in 1st Sem. on merit basis will be admitted with 50% concession on total fees.
2. The Library Caution deposit refundable amount of Rs.500.00 been excluded in the fee structure due to non issue of books but the reading facility will be available, however to issue books in future the students will have to deposit the caution deposit at the college office.
3. The KLC Student Union is also kept in abeyance due to unable to conduct student activities by the College. Further when necessary the required fees may be collected by the students union of the college.

The admitted students must follow the BCI rules & regulations while pursuing the 3 years L.L.B. course to appear the End Semester Examination:

No student of any of the degree program shall be allowed to take the end semester test in a subject if the student concerned has not attended minimum of 70% of the classes held in the subject concerned as also the moot court room exercises, tutorials and practical training conducted in the subject taken together. Provided that if a student for any exceptional reasons fail to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education, as the case may be, may allow the student to take the test if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together. The similar power shall rest with the Vice Chancellor or Director of a National Law University, or his authorized representative in the absence of the Dean of Law. Provided, further that a list of such students allowed taking the test with reasons recorded be forwarded to the Bar Council of India.

The Gauhati University guidelines in regard to the conduct of Session Test, Seminars and assignments time to time within the semester period are mandatory for all the students of the college. Failing to attend the same will face consequences accordingly because it is the part of the academic practice which involves continuous comprehensive evaluation system.

The ragging is completely banned in the College and being the legal education institute all forms of harassment, unlawful activities are banned within the campus. Ragging is a crime and it ruins the innocent lives and careers at any stage of attaining higher education. There will be strong monitoring and students are expected to cooperate with the college authority in such cases and to spread the awareness against ragging across the campus and society.

College Uniform Regulation:

The students have to come with prescribed college uniform in all the class days except on Tuesday (Own Traditional dress). This is mandatory for all semesters.

Dress code & colour:

For Girls:

1. **Black Trouser and White Shirt with black shoes.**
Or
2. **Black Salwar and White kameez with black dupatta and black shoes.**
Or
3. **Black and White Combination Dokhona/Saree/Mekhela/ or any other ethnic wear with black shoes.**

For Boys:

1. **Black Trouser, white shirt, black tie and black shoes with white socks**

NB: Black Blazer is compulsory during winters for both boys and girls.

Important Dates:
